THOUSAND HILLS BAPTIST ASSOCIATION, INC. ASSOCIATIONAL CONSTITUTION

I MISSION:

To assist churches in church development, missions, evangelism, and discipleship in order to advance the kingdom of Christ.

II MEMBERSHIP:

Section 1: The membership shall consist of Southern Baptist Churches that voluntarily cooperate with the association, the Missouri Baptist Convention, and the Southern Baptist Convention.

Section 2: Any church desiring to cooperate with this association shall send a letter of petition to the executive board of the association at least six months before the annual meeting. The executive board shall appoint a committee (ad hoc) to examine the church. If the church is found to be sound in doctrine and cooperative in nature, this committee will recommend the church for membership. The committee will report their recommendation to the executive board and present it to the messengers for a vote at the annual meeting.

Section 3: Cooperating churches are requested to send messengers to the association's annual meeting; contribute financially to the association; and submit an annual church profile before the annual meeting.

Section 4: A member church may withdraw from the association at any time, by informing the associational clerk in writing.

Section 5: The association reserves the right to withdraw fellowship from any church that becomes unsound in doctrine and/or uncooperative in nature. The executive board shall carefully investigate the matter and make the recommendation to withdraw fellowship at the annual meeting. If it is recommended to withdraw fellowship, the executive board shall send written notice to the church involved, as well as to all member churches at least two months before the annual meeting. A two-thirds majority vote of the messengers at the annual meeting shall be required.

Section 6: Doctrinal soundness shall be defined by God's Word as explained by the current Baptist Faith and Message and/or any historical Southern Baptist Doctrinal statements.

III MESSENGERS:

Section 1: The annual meeting will be held the second Sunday in the month of September at 3:00 pm with the evening session being a worship service. A quorum shall consist of fifty-one percent of all the eligible messengers as reported on the Annual Church Profile.

Section 2: Each church shall be entitled to three messengers and one additional messenger for each fifty, or fraction of fifty, resident members as reported on the Annual Church Profile. No church shall have more than eight messengers. The Senior Pastor shall be recognized as a messenger of the church and shall be counted as one of the church's messengers.

Proposed addition: Alternate messengers may also be elected and may serve as the church's messengers in the absence of the church's messengers if they are unable to attend the annual meeting. The church may elect alternate messengers up to the same amount of messengers as they are entitled to elect.

IV OFFICERS:

Section 1: The officers of the association shall consist of a moderator, assistant moderator, clerk, assistant clerk, treasurer, and assistant treasurer. Terms of office will begin at the conclusion of the annual meeting with the exception of the treasurer and assistant treasurer whose term will begin the first day of January.

V THE EXECUTIVE BOARD:

Section 1: The Executive Board shall consist of the officers of the association, pastors of all the member churches, and one member elected by each church.

Proposed addition: One alternate executive board member may be elected by each church to serve in the absence of their elected board member at the executive board meetings.

Section 2: The Executive Board shall conduct all business of the association between annual meetings in accordance with the provisions of this Constitution and By-Laws. The Executive Board minutes will be submitted at the annual meeting. Business at both the Executive Board Meetings and the Annual Meeting will be conducted according to the latest edition of Roberts Rules of Order.

Section 3: A quorum shall be twelve of the members of the Executive Board. The Board shall meet January, April, and July on the fourth Thursday of the respective months.

Section 4: The Director of Missions shall be an ex-officio member of the Executive Board.

VI DISSOLUTION:

The association may be dissolved by a vote of two-thirds of the messengers present at a called or regular meeting of the association. The intent to make such a motion must be given to the moderator and DOM at least one month before the meeting. Any motion of dissolution must include the transfer of the financial assets and of the property of the association to some new Missouri Baptist association or to some other Missouri Baptist Convention or Southern Baptist entity.

VII AMENDMENTS:

This constitution may be amended by a two-thirds majority vote. The amendment(s) must be presented in writing at an annual meeting and voted on in the next annual meeting.

ASSOCIATIONAL BY-LAWS

ARTICLE I – OFFICERS

A. Election of Officers

1. All officers shall be nominated by the nominating committee or from the floor at the annual meeting of the messengers and shall be elected by a majority vote of the messengers present at the annual meeting.

2. The moderator and the assistant moderator shall serve no more than two full successive terms. A lapse of one full associational year shall occur before a former moderator or assistant moderator is eligible for reelection to this office.

B. MODERATOR

1. Shall prepare a written agenda for the annual and executive board meetings.

2. Shall have the authority to convene special meetings of the Executive Board and/or the Association.

3. Shall serve as leader of the Leadership Council.

C. ASSISTANT MODERATOR

Shall carry out the responsibilities of the moderator in the absence of the moderator or as requested by the moderator.

D. CLERK

- 1. Shall record the minutes of the annual meeting and all Executive Board meetings.
- 2. Shall submit minutes of the previous meeting for approval.

3. The Clerk shall be responsible for gathering and compiling statistics from the Annual Church Profile, and shall present them to the association at annual meeting, and shall forward them to Lifeway.

E. ASSISTANT CLERK

Shall carry out the responsibilities of the clerk in the absence of the clerk or as requested by the clerk.

F. TREASURER

1. Shall deposit the receipts of the association and disburse them according to the annual budget or as the Executive Board instructs.

- 2. Shall keep accurate and timely records according to accepted bookkeeping standards.
- 3. Shall be bonded.
- 4. Shall provide financial reports at the Executive Board meetings and at the annual meeting.

G. ASSISTANT TREASURER

1. Shall carry out the responsibilities of the treasurer in the absence of the treasurer or as requested by the treasurer.

- 2. Shall be bonded.
- H. The associational year will be January 1 December 31.

ARTICLE II - DIRECTOR OF MISSIONS

- A. Shall work closely with and report to the Executive Board.
- B. Shall be an ex-officio member of all committees, councils, and teams.
- C. Shall work in accordance with the job description as approved by the Executive Board or the association.
- D. When the position of Director of Missions is vacant, a search committee will be formed (see ad hoc committees Article III B.)
 The search committee will be responsible for a job description and the benefits package, which will be presented to the Executive Board for approval at a regularly scheduled or a special called meeting.
- E. The nominee recommended by the search committee for the office of Director of Missions shall be called by a majority vote of a special called meeting of the Executive Board of the association.

ARTICLE III – COMMITTEES

A. NOMINATING COMMITTEE

- 1. Shall consist of six persons who will serve two-year rotations.
- 2. Shall be nominated by the Leadership Council and elected at the annual meeting with terms as designated.
- **3.** Shall attempt to nominate a geographically balanced slate of proposed officers for the coming year by the spring Executive Board meeting to be elected in the Annual meeting.
- 4. Shall present to the Executive Board names to fill any vacancies that occur during the year.

B. AD HOC COMMITTEES

1. Will be nominated by the Leadership Council and presented to the Executive Board or to the association annual meeting for approval.

C. FINANCE COMMITTEE

- 1. The Leadership Council and the DOM will serve as the Finance Committee.
- 2. The budget will be presented for approval at the annual meeting.

D. SEARCH COMMITTEE

- 1. Shall be composed of five members.
- 2. The Leadership Council shall nominate five persons for the Search Committee to be approved by the Executive Board.

ARTICLE IV - ASSOCIATIONAL LEADERSHIP COUNCIL

A. PURPOSE

The purpose of the Associational Leadership Council will be to lead the association to fulfill the mission of the association.

B. COUNCIL MEMBERS

- 1. Council members will include officers of the association.
- 2. The leader will be the Moderator of the association.

C. DUTIES...The Council will organize itself to accomplish the following:

- 1. Coordinate the administrative matters of the association.
- 2. Serve as the Finance Committee.
- Bring nominations for members of the Nominating Committee, with the chairman designated, to the annual meeting.
 Bring nominations for ministry coordinators and expected duties to the Executive Board for
- approval and recommendation to the Annual meeting.4. The Leadership Council will present to the Executive Board annually an evaluation of the association's ministries and staff members.
- 5. Report regularly to the Executive Board and to the annual meeting. Schedule council meetings at least quarterly.

Article V – ASSOCIATION MINISTRY COUNCIL

A. PURPOSE

The purpose of the Associational Ministry Council will be to lead the Association to coordinate ministries and provide training and encouragement for the churches.

B. COUNCIL MEMBERS

- 1. The Council members will include ministry coordinators of the various ministries of the Association.
- 2. The Director of Missions will be the leader of the council.

C. DUTIES

- 1. Develop strategies and plans for Association ministries.
- 2. Coordinate the Association calendar.
- 3. Each coordinator may enlist volunteers to serve as a team to accomplish ministries.
- 4. Meet prior to the winter and summer Executive Board meetings and bring Recommendations to the Executive Board and Annual meeting.

ARTICLE VI – AMENDMENTS

The by-laws may be amended at the annual meeting by a majority vote of the messengers present and voting, provided the motion to amend is presented to the moderator for distribution to the churches two months before the annual meeting.

Thousand Hills Baptist Association Annual Meeting September 12, 2021

The annual meeting of the Thousand Hills Baptist Association was held Sunday, September 12, 2021, at Hamilton Street Baptist Church. Messenger registration began at 2:30 pm with the business meeting following at 3:00 pm. Moderator Larry Aeschliman called the meeting to order. Pastor Garrett Trunk welcomed everyone to the meeting and opened in prayer. The Hamilton Street Worship team led the congregation in a hymn.

Pastor Curtis Ferguson of Rehoboth Baptist Church presented the Theme Interpretation for the Annual Meeting.

Thousand Hills Baptist Association Revitalization Team Report ReFocus Strategy

Greetings Thousand Hills Churches:

During the July 2021 Executive Board Meeting, the Thousand Hills Baptist Association (THBA) Executive Board Members voted to form a Revitalization Team to develop a strategy that would help us restore purpose and vitality to our association. The leadership council enlisted the following pastors to serve on this team: Phil Bray, Sam Burkholder, Mark Drummond, Chance Glenn, Justin Honey, Jason Marlin, Steven Nelson, Zachary Rohman, and B.J. McAlpin. As DOM, Richard Nations also served on this team. Not every pastor was able to serve for the entire year, but we are grateful for each man's contribution.

We are also grateful for the leadership provided by John Vernon and Brandon Moore. John Vernon serves as Director of Missions for Cape Girardeau Baptist Association and Brandon Moore serves as Revitalization Network Specialist for the Missouri Baptist Convention. Together, these two men led our team through REFOCUS, a six-step revitalization process, to help us restore purpose and vitality to the partnership of the THBA churches.

Below you will find an outline of discoveries made and new proposals to be presented at the September 2022 THBA annual meeting.

DISCOVERY: During the discovery step we sought to answer the question, **"How are things going?**"

- We need to come up with a clear definition (philosophy) for the association. We did reach the conclusion that <u>the association is "a group of churches" working together</u> collaboratively versus "a separate, church supported entity unto itself". This led us to see that <u>the primary focus and responsibility is on churches</u>. Given history this creates a strong need for clear expectations that are constantly, consistently communicated.
- 2. We need a vision that provides greater clarity for why we associate.
- 3. We need a strategy.
- 4. **There is hope**, expressed in the following ways:
 - 1. Other pastors believe there is a collective desire to fulfill the Great Commission.
 - 2. We are seeing the same need for vision/strategy
 - 3. We have unity that can produce effectiveness.
- 5. While the associational giving has been declining, the finances of the local churches are actually increasing. People make choices with their money as they strive to steward well. The Block Party Trailer demonstrated this as the funding for it came relatively quickly.
- 6. The leadership structure is not poised for new vision/strategy.
- 7. There are things we can learn from Camp Ministry in regard to the way we can cooperatively work and minister together.

<u>CONVERGENCE:</u> During the convergence step we sought to answer the question, "Where should we position the ministry?" or "How should our churches partner together to effect Kingdom Growth?"

- 1. The "Big Idea": The **churches assisting one another to health**. Developed from the keywords: Assist, One another, Health.



Director of Missions Report

Richard Nations, DOM

This is the tenth year I have served as director of missions for Thousand Hills Baptist Association. Thanks for your support and encouragement to me as I minister among our churches. We have some really vibrant and exciting churches in our association and I'm glad to be associated together with you. There are also some churches that are struggling and we need to work together to make sure none are left behind.

Partnership is a beautiful thing when it is done well, and stronger churches come alongside struggling churches to make sure that the Gospel is spread to all communities. Have you asked a church in your region if there are things you can do to help them in their mission? Maybe they don't have a pastor or maybe they don't have teenagers or children attending. There are actions you can take to help them with these needs. Have you considered that?

The Revitalization Team has presented their report and they are urging us to "assist one another" as we look out over our landscape of communities and churches. Let's organize ourselves to do just that.

Summer camps have once again proven to be one of the most effective things we do as an association. I am so pleased we were able to join with our partner, Linn-Livingston Baptist Association, to help both of us have youth and children's camps. God really moved in the children's camp with many receiving Jesus as Savior and Lord. Great work camp team!

VBS is always a great strategy for a church, and we are glad that the association could train VBS workers in two seminars and many churches used this effective tool to reach out to children and their families this summer. Many thanks to our VBS team and coordinator.

In evangelism and missions there were several mission trips taken by churches. The THBA assisted with a mission trip to Wisconsin, New York, and Alaska. And there were six who traveled to Sedalia to share Christ at the Baptist Tent at the Missouri State Fair. Six professions of faith were recorded the day THBA volunteers served and there were 78 professions of faith recorded during the 10-day fair. We were one of 13 associations and 9 churches who shared Christ at the fair. I observed three people from our association who gave their lives to Christ there in Sedalia.

We value our regional, state, and national partners in ministry. Here in north Missouri, we assist the Baptist Student Union at Truman State (Greg Xander, campus missionary) and the Grand Oaks Baptist Assembly, Chillicothe (Brad Fields, manager). Our Missouri Baptist Convention partners with us on many fronts and I am glad to be part of their team in Disaster Relief as well as a contributing writer for The Pathway newspaper. I also usually write the Missouri Mission Offering prayer materials distributed in September.

And let me say a word about our national partner, the Southern Baptist Convention. Our joint support of ministries through the Cooperative Program, the International and North American Mission Boards and our six SBC seminaries is the glue that holds us together. We should cooperate fully to support missions efforts through the SBC Cooperative Program.

Now recently there have been some disturbing things that have been uncovered. The toleration and cover up of sexual abuse within churches, entities and even at the highest levels in our SBC Executive Committee should not have been allowed to happen. I am glad the SBC messengers demanded a full investigation and accounting for this misbehavior. Now that it is in the open, let's fix the problem and pull back together to support our convention. Now is not the time to leave the SBC. It is the time to call for full accountability. Let's make sure no one is allowed to be abused in our churches.

By the time I give this report, I assume that the association has adopted the report of the Revitalization Team. Therefore our new purpose statement and mission statement are now ours to claim:

Purpose: "Assisting one another to bring Christ to our communities." Vision: "We want to see Christ bring health to our churches and our communities."

So let's unite together under those statements. Thank you for letting me lead you in this association.

Worship/Fellowship Report

A few years ago I was elected to serve as your Association's leader in the area of Worship and Fellowship. It was my heart to seek out to assist and be a resource for those churches of our association who desired to improve the area of congregational worship and fellowship. Executive Board Staff Reports

Collegiate Ministries Gene Austin, Director

The pandemic is over – kind of. Unfortunately, it's still affecting our campuses. Over the past two years, many incoming students have spent significant time in an online school. Even so, we saw an increase in almost every area of ministry we track.

We saw a 37 percent increase in students that had some contact with one of our ministries. This resulted in 58 more college students coming to faith and following Jesus. Our mission trips and other activities saw more than 200 people receive Christ. The number of students involved in Bible study or small groups was over 1,000, up from about 400. International student involvement went up by 150 percent. More than 100 summer missionaries served at Super Summer, associational camps, VBS, and other ministries around the state.

God was and is moving in the ministries of mbCollegiate and the MBC. We give Him praise for what He did and continues to do. Our campus missionaries on 28 different campuses were a massive part of these results and continue to faithfully and effectively serve.

New ministries

Our agreement with Concord Baptist Association enhances the effectiveness of the ministry to the Lincoln University campus. The association has deeded its building back to the MBC and moved its offices to the Baptist Building. This allows Lincoln's BSU to have full-time space for ministry and outreach on campus.

In addition, Soma Community Church also uses the facility to reach the community, including the campus.

We are also excited about launching two new ministries: one at Mizzou and another at State Tech in Linn. At Mizzou, connections are already happening with students and churches in the Columbia area. This ministry is partnering with the Heart of Missouri Baptist Association to see a dynamic ministry calling students to become multiplying disciple-makers, servant leaders, and missionaries wherever they are.

Pastors in the area prayed for a ministry at State Tech for many years, and now it is a reality. It is exciting for area churches and the association to partner to reach these college students.

God is moving at Mizzou, State Tech, and all the ministries of mbCollegiate.

Developing Leaders Jim Misloski, Director

The Developing Leaders Group is composed of the Resound Network for church revitalization, Missouri Baptist Disaster Relief, and the MBC Leader Care Network.

The MBC Leader Care Network exists to help leaders get well, lead well, and finish well. Members cooperate with Missouri Baptist associational leaders to create a network of support for Missouri

Baptist church leaders and their families. The network of support includes resources for coaching, counseling, conflict resolution, assistance with planning pastoral wellness retreats and sabbaticals, and equipping through the Midwest Leadership Summit. Detailed information about the MBC Leader Care Network is available online at *mobaptist.org/helpforleaders*.

In the 2021-2022 season, the MBC Leader Care Network provided support to more than 320 MBC churches and leaders. Requests to the network continue to increase in each successive season. The greatest challenge is the limited capacity of the network. In the spring of 2022, the Developing Leaders Group partnered with the Montana Southern Baptist Convention to provide a leadership development initiative to 35 Montana Baptist church leaders. Missouri's part in the initiative ended in July 2022 and resulted in the formation of two regional pastoral cohorts, who continue to encourage and develop Montana Baptist church leaders.

Brandon Moore, Church Revitalization & Replanting

Prayerfully seeking a movement of God, the Resound Network has mobilized leaders across Missouri to catalyze revitalization and replanting through partnerships in a variety of contexts. The network focuses on three priorities: equipping leaders, engaging churches, and encouraging multiplication.

The statewide Resound Network Summit hosted more than 70pastors and directors of missions (DOMs) for equipping as revitalizers and consultants. Three Regional Summits and pastoral luncheons were hosted across the state to equip more than 100 local leaders. The Resound Summer Cohort equipped 17 leaders for revitalization and replanting, including five MBC collegiate interns receiving credit through Midwestern Baptist Theological Seminary.

The Resound Network hosted its second annual panel at the 2021 MBC Annual Meeting, during which 60 pastors and lay leaders were challenged to develop revitalizers and replanters in their own churches. Nine churches have embraced recommendations to revitalize, replant, or repurpose, and an additional 11 churches have started the Resound process. Lastly, to encourage multiplication, the network hosted the first Partnership Summit with more than 40 pastors and DOMs who worked together to utilize the principles discussed to determine next steps toward partnering with struggling churches.

Gaylon Moss, Disaster Relief

Missouri Baptist Disaster Relief (MODR) transforms lives and communities with the gospel by bringing help, hope, and healing. Churches participate in MODR by praying, giving, and going. MODR helps churches by providing leadership, discipleship, and sending opportunities. MODR is a platform for ministry.

From July 2021 – June 2022, MODR teams served in-state, nationally, and internationally. During this timeframe, 11 people became new believers.

Hurricane Ida provided MODR the challenge of securing, preparing, and serving approximately 23,000 hot meals without support from traditional national partners.

A deadly tornado outbreak in December saw MODR serving in Missouri and Kentucky. Since then, we have launched an effort to repair/rebuild four homes in the Missouri Bootheel affected by this tornado outbreak.

MODR provided fire recovery in Colorado and New Mexico, raised funds to help with the 2021 Haiti earthquake, and provided funds for domestic reception of Afghan refugees.

The war in Ukraine was a worldwide disrupter. We saw four teams of MODR volunteers serve Ukrainian refugees on the Romania/Ukraine border. In addition, Missouri Baptists provided 40,000 meals for Ukrainians through national and international partners. The food was purchased and prepared in Ukraine and distributed by Ukrainian Baptist churches, and the gospel was shared.

Executive Office Dr. John Yeats, Executive Director-Treasurer

Don Hinkle, The Pathway

On June 8, The Pathway marked its 20th anniversary, and it once again set another circulation record, approaching 30,000 subscribers, making it the fourth-largest paid circulation newspaper in Missouri. Additionally, more than 40,000 Missourians visited The Pathway website over the past year, along with another 10,000-plus coming from other states and nations. Estimated total readership of The Pathway has topped 100,000, with 60,000 due to the print edition. The Pathway is read in 115 countries.

In April, The Pathway's Associate Editor Ben Hawkins won a writing award for news from the Evangelical Press Association. Copies of The Pathway are sent to missionaries around the world. In addition, the newspaper is in three state prison libraries, the Missouri State Capitol, and is provided to every member of the Missouri General Assembly and statewide officeholder. It is also provided to the presidents of every Southern Baptist Convention (SBC) entity and to members of the SBC Executive Committee.

Don Hinkle completed his 20th year as the only editor The Pathway has ever had. It has become a nationally respected publication for espousing a biblical worldview approach to journalism.

The Pathway is made possible at no cost to subscribers through the support of Missouri Baptists to the Cooperative Program.

Business Services & Properties Management

Samantha Spencer, Controller

The Business Services Group is the Cooperative Program's entry portal for the MBC. The group accounts for all church receipts and allocates the monies to the appropriate ministries and missions. The receipts processed by Business Services for the year ending Dec. 31, 2021 are as follows:

Gene Foster, Church Benefits Specialist

Gene Foster, Church Benefits Specialist, helped churches with retirement plans this year. He held compensation-planning seminars and church tax-filing seminars for different associations throughout the state.

He assisted Missouri Baptists with church-finance, personnel, pastor-search, and payroll tax questions, retirement plan set up, and church compensation and financial issues.

Paula Earls, Operations Manager

Paula Earls, the MBC's Operations Manager, administers the MBC retirement plan, property and casualty insurance policy, and personnel policies and benefits. She serves as the main point person for the activities and leases at the Baptist Building in Jefferson City.

Over the past year, she completed insurance applications, assisted with claim requests, responded to insurance-coverage questions, and much more.

Other work includes planning the MBC Annual Meeting and other statewide meetings throughout the year. She additionally assists with various special projects as assigned.

Brooks Crawford, Properties Management Specialist

The Properties Management staff maintains the Jefferson City convention building, High Point Road Conference Center, Disaster Relief warehouse, six BSU buildings, and the MBC fleet of vehicles and trailers.

The staff serves by cleaning, setting up for meetings, conducting light construction, and doing repairs and regular maintenance at these locations.

Staff members are continuing to update/renovate most parts of the Baptist Building, with the third, fourth, fifth, sixth, and seventh floors completed. Remodeling of the ground floor is nearly completed.

Spencer Hutson, Liaison/Strategic Partners

Spencer Hutson serves as liaison to Missouri Baptist associations. He works closely with the DOM Fellowship in planning the spring and fall conferences that provide continuing education, best practices, and fellowship opportunities. The group continues to have regular Zoom meetings, and most regions have additional collaboration within the region.

Hutson, who now works with Baptist Homes & Healthcare Ministries as the church relations specialist, continues to serve as a contract worker with the MBC under the framework of the Leadership Development Group and alongside its director, Jim Misloski. In addition, he assists churches with facilities needs and stewardship ministry.

Cheryl Stahlman, Missouri WMU Executive Director

Missouri Woman's Missionary Union has been blessed by God this past year through opportunities to build up its leadership team.

The MWMU held its 98th Annual Missions Celebration at First Baptist Church in Lake St. Louis, Mo, on Sept. 10-11, 2021, after having to postpone it from the traditional dates in April. This meeting was well attended as we heard from National WMU Executive Director/Treasurer Sandy Wisdom-Martin, IMB and NAMB missionaries, and more. Just seven months later, MWMU held its 99th Annual Missions Celebration at Concord Baptist Church in Jefferson City, hearing from National WMU President Connie Dixon, IMB and NAMB missionaries, and others.

Over the last year, MWMU has been able to help Oasis International with a HEART Grant from the WMU Foundation to help provide gift cards to refugees coming into St. Louis.

Missouri PrayerWays continues to impact our International Mission Board and North American Mission Board missionaries from Missouri. They know their state is praying for them, and many plan events and services on their birthdays with that in mind.

Missions Exploration was held in October 2021 with 69 in attendance. G.E.M. (Girls Experiencing Missions) was held in October 2022 at Concord Baptist in Jefferson City.

MWMU state staff, president, and vice president were blessed to be trained one-on-one with the National WMU in November 2021 after two years of training online.

R.A. Congress was held in April with more than 150 participating in sports activities, archery, pine cars, mission run, and more. They were challenged by missionaries and collected items for the Missouri Baptist Children's Home.

Three offerings met or exceeded their goals this year, with MMO at \$824,446, Lottie Moon at \$4,154,582, and Annie Armstrong at \$2,410,452. What an amazing testimony of how God uses us as we partner together to make disciples for Christ.

Making Disciples

Brad Bennett, Director

The mission of the Making Disciples Group is to cultivate a gospel-centered culture and community of disciple making in Missouri Baptist churches.

In the past year, the Making Disciples Group has held numerous age-graded disciple- making equipping events. Below are just a few:

LIFE Outreach

LIFE Outreach is a community-wide equipping and outreach event. A LIFE Outreach was held this year in Caruthersville, Mo., with more than 500 in attendance and 55 people surrendering their lives to Christ. There are eight scheduled events this fall in various Missouri communities.

Super Summer Camp

In June 2022, the Making Disciples Group hosted two weeks of Super Summer on the campuses of Hannibal-LaGrange University and Southwest Baptist University. More than seven hundred attended and many surrendered their lives to Christ.

Youth Evangelism Conference

The 2022 Youth Evangelism Conference was held at Calvary Baptist Church of Republic, Mo. More than 400 attended in person. YEC was held to inspire, instruct, and encourage students to share their faith.

Vacation Bible School

The Making Disciples Group held four VBS associational trainings in 2022, with 125 in attendance.

Ministry Support & Apologetics

Rob Phillips, Director

The Ministry Support & Apologetics Group provides the state missionary staff with creative services, media and technology support, and assistance with the staging and production of MBC events.

Creative Services (CS) promotes the Cooperative Program through ads, videos, articles, and social media, partnering with MBC entities to show the value of our cooperative ministries. The group also promotes the Missouri Missions Offering, producing print and electronic resources that show the impact of more than two dozen mission projects across the state.

CS named Tony Boes group leader, and welcomed videographer Neil Sneed and graphic designer Ryan Lake early in 2022. CS continues to add features to proprietary apps; expand the role of video in MBC ministries; and keep the convention's presence on social media one of the most active among SBC state conventions.

CS also works closely with High Street Press, the MBC's publishing imprint, releasing four books in 2022, including Understanding The Baptist Faith & Message.

In Media, Technology & Events (MT&E), the staff continues to improve the speed and reliability of information networks, enhance the convention's database, increase participation in the Annual Church Profile, and lower the cost of IT services.

MT&E also provides superior audio-visual and set design support for all major MBC events.

Multiplying Churches

Rick Hedger, Director

Envision a day when it would be impossible for a people to dwell within the borders of Missouri without an MBC church owning the responsibility to evangelize and plant a church among them. This is the mission impossible guiding the Multiplying Churches Group.

Providing demographic reports to any church or association is a beginning step to discovering the peoples that have come to dwell within their sphere of influence. Once a people are discovered, the Multiplying Churches Group strategically develops interested local churches and associations in an appropriate strategy to engage, evangelize, and establish a fledgling church among the people. Once developed, the interested churches are guided in engaging the people with the gospel. This is called a discipleship-oriented church planting strategy.

Additionally, the MBC has in excess of 200 churches without a pastor on a weekly basis. The Multiplying Churches Group has a goal to encourage and assist 50 pastors to mentor potential pastors who may step into one of these churches, start a disciple-oriented church start, or join NAMB in its funded church-planting model. Interested pastors could receive \$2,400 to assist with this strategy.

Strategic Partners Reports

Missouri Baptist Children's Home

Russell Martin, President and Treasurer

"Missouri Baptist Children's Home is committed to serving God by responding to the needs of children, youth and families to make a lasting difference in their lives."

More than 90 percent of all ministries were provided in community-based programs rather than on a residential campus.

In 2021, MBCH and The LIGHT House touched the lives of 4,707 children and families.

Two hundred and six children found loving, forever families.

Thirty-six youth were served in therapeutic group homes.

Two hundred fifty-six mothers and babies were served through Pregnancy Services provided by MBCH and The LIGHT House.

One hundred thirty-five children were in treatment family care homes and 347 children and youth were in family foster homes.

MBCH maintained 356 foster/adoptive and/or relative/kinship homes.

Twenty-two young women were served through the human trafficking rescue ministry.

Transitional living programs in Bridgeton, Springfield, and Mt. Vernon served 57 young people as they prepared to leave foster care and become independent.

Sixteen adults with developmental disabilities received care at Country Haven or The Branches at Brookline.

The Counseling Center provided services to 96 clients.

Six hundred ninety-five people were trained in Stewards of Children sexual abuse prevention. There were five professions of faith by children served in residential programs of MBCH.

Southwest Baptist University

This past year, the focus for SBU has been the three D's of student-focused initiatives: dining, dorms, and discipleship. SBU has partnered with a new food service called Provider. Our dorm lobbies are being renovated to continue to create a sense of belonging in the place our students call home. Missouri Baptist University

The past few years have highlighted the growing need for healthcare professionals, especially those with a Christian worldview. Missouri Baptist University is rising to meet that need.

MBU's new Master of Science in Nursing degree equips individuals to combine clinical expertise and a passion for patient care, while the new Accelerated Bachelor of Science in Nursing program allows students to expedite the RN licensure process, helping fill the growing number of healthcare vacancies.

On the mental health side, recent accreditation by the Council for Accreditation of Counseling and Related Educational Proposals validates MBU's rigorous counseling program, which is one of the only faith-based counseling degrees in the region.

Finally, one example of the blending of faith, learning, and practice is a recent School of Nursing mission trip to the Republic of Liberia. Students taught resuscitation with a bag and mask device to local midwives to help newborn babies breathe more effectively. They also hosted a medical clinic to treat ailments ranging from nausea to malaria.

These highlights provide but a few examples of the many ways MBU is enriching students spiritually, intellectually, and professionally, preparing them for lives of service and leadership all over the world.
